Driving Directions

From the East:

Merge onto I-64 West toward Richmond. Merge onto I-64 West via Exit 79 toward Powhite Parkway/Charlottesville. Merge onto West Broad Street (US 250 East) via 178B toward Richmond. Turn right onto Cox Road. Turn left onto Westerre Parkway. Pass the Shoppes at Twin Oak. Turn right onto Twin Oaks Commons at Westerre Commons. Turn immediately left after Primrose day Care. The one-story condominium office building #3721 will be on the first row; we are the middle suite in the building.

From the West:

I-64 E toward Richmond. Merge onto West Broad Street (US 250 East) via Exit 178B toward Richmond. Turn right onto Cox Road. Turn left onto Westerre Parkway. Pass the Shoppes at Twin Oak. Turn right onto Twin Oaks Commons at Westerre Commons. Turn immediately left after Primrose day Care. The one-story condominium office building #3721 will be on the first row; we are the middle suite in the building.

From the North:

I-95 South toward Richmond. Take the I-295 exit (84B) toward Charlottesville. Take the US-1 exit on the left toward Richmond. Merge onto I-295 North via the exit on the LEFT toward I-64 West/Charlottesville. Merge onto I-64 East via Exit 53B toward US-250/ Richmond. Merge onto West Broad Street (US -250 East) via Exit 178B toward Richmond. Turn right onto Cox Road. Turn left onto Westerre Parkway. Pass the Shoppes at Twin Oak. Turn right onto Twin Oaks Commons at Westerre Commons. Turn immediately left after Primrose day Care. The one-story condominium office building #3721 will be on the first row; we are the middle suite in the building.

From the South:

I-95 North toward Richmond. Merge onto I-64 West via Exit 79 toward Powhite Parkway/ Charlottesville. Merge onto West Broad Street (US-250) via Exit 178B toward Richmond. Turn right onto Cox Road.
